Excerpt from the Statute of the Non-profit Association for animal welfare and protection "Pet Mondo":

Members of the Association can be initial, active, passive and honorable.

Initial member is the person who filled in the application form for membership/renewal. Initial members may receive notification of the work, activities and program of the Association, but do not have the right to make decisions related to the work of the Association and can not be elected to the management bodies. Accessible members have the right to participate in the Assembly's meetings as observers. The initial member that pays an annual membership fee becomes a passive member.

An active member of the Association is an individual who fully accepts the goals of the Association and confirms it by selecting active membership in the Pet Mondo membership/renewal form. Active member achieves his status based on a decision of the Management Board. The Management Board of the Association has the right to reject the request for an active membership. An active member of the association can only be the person who paid the membership fee for the current year. Active members have the right to participate in the work of the Association, make decisions and be elected to management positions.

An honorary member of the Association may become any individual or a legal entity who has significantly contributed to the work of the Association. Any member of the Association can submit a proposal for the honorary membership. The decision is made by the Assembly. The honorary member does not pay the membership fee and has no right to make decisions related to the work of the Association, to choose or to be elected to the bodies of the Association.
